Harambee is an East African Swahili word meaning "Let's Pull Together" or "Unity," originally created as a safe alternative to trick-or-treating for kids. This year's theme is "Keeping It Clean & Green," motivating the community to choose healthier ways of life to improve their quality of life. The Harambee Festival's overall mission is to educate and unify all generations, cultures, and social groups, while providing a positive and family-friendly atmosphere for everyone.

Participating in the Harambee Festival gives you the opportunity to showcase and promote your business, while enjoying the cultural diversity the City of Dallas has to offer. This is a free event, scheduled for Saturday, October 26, 2019, from 10:00 a.m. to 6:00 p.m.

The vendor fee is \$75, which can be paid via Gift Card, Money Order, or Cashier's Check, made payable to Harambee.
